Subject: ELIGIBILITY OF THE EMPLOYEES OF FBR AND ITS FIELD FORMATION /REGIONAL OFFICER FOR ALLOTMENT OF THE GOVERNMENT ACCOMMODATIONS FROM THE POOL OF THE ESTATE OFFICE.

I am directed to refer to the subject cited above and to state that the employees of the Collectorate of Customs, Central Exercise and Sales Tax and Directorate of Central Intelligence and Investigation (Custom & Excise) and Regional Offices located at Lahore, Karachi, Quetta, Peshawar and Rawalpindi were declared ineligible for allotment of government accommodations from Estate Office Pool being sub-office of FBR vide this Ministry's letter No. F1022/2007/EIII dated 4.10.2007 & F. No. 2(8)/2007-Policy dated 8.4.2008.

2. The matter was re-examined and was referred to Establishment Division (Management Service Wing) in the light of the Supreme Court Judgment dated 21.11.2014 in Civil Appeal No. 599 to 602 of 2014, CMA No. 3434 of 2014, CMA No. 4915 and C.A. NO. 1547 of 2014. The Establishment Division (Management Service Wing) Vide O.M No.12-1/20174-MSW-IV dated 15.1.2018 informed that Federal Board of Revenue (FBR) including its field formations/Regional Offices falls in the category of "an Attached Department" of Revenue Division. The FBR including its field formations/Regional Offices are, therefore, eligible for allotment of Government accommodation from the Estate Office pool in term of the Rule 3(1) of Accommodation Allocation Rules, 2002.
